PRIVACY POLICY

CC&L Bsurre Financial Services (Pty) Ltd t/a Bsurre strongly believes in protecting your privacy and the confidentiality of your personal information. In order to explain how CC&L Bsurre Financial Services (Pty) Ltd t/a Bsurre collects, uses and protects personal information, we have developed this privacy policy. Personal information is any combination of information, in the possession of, or likely to come into the possession of CC&L Bsurre Financial Services (Pty) Ltd t/a Bsurre that can be used to identify, contact, or locate a discrete individual ("Personal Information") and will be treated in accordance with this privacy policy. Website usage information is collected using "cookies" which allows us to collect standard internet visitor usage information.

HOW WE USE YOUR INFORMATION
